A judge's "duty of care" refers to their legal obligation to exercise a reasonable standard of care in their judicial decisions, meaning they must act with fairness, impartiality, and thoroughness when considering cases, avoiding any actions that could foreseeably harm the parties involved, and upholding the integrity of the legal system; essentially, they must make decisions based on the law and evidence presented, not personal bias or prejudice.

Key aspects of a judge's duty of care include:

- Impartiality: Judges must not show favoritism or bias towards any party in a case. @
- Thorough review of evidence: Carefully examining all relevant facts and legal arguments presented before making a decision.
- Following legal precedent: Applying existing laws and interpretations consistently in their rulings.
- Avoiding conflicts of interest: Disqualifying themselves from cases where they have a personal connection to the parties involved.
- Maintaining decorum: Conducting court proceedings with appropriate dignity and respect for all participants.

Breach of duty of care by a judge:

- · Making decisions based on personal biases or prejudice
- · Failing to properly review evidence or legal arguments
- · Engaging in inappropriate behavior that could influence their decision-making
- Appearing to be biased or unfair in their conduct




